## A - Ordinary business

## 1) Audited Financial Statements

The Audited Consolidated Financial Statements of the Company for the financial year ended 31 December 2022, together with the Directors' Report and Auditors' Report thereon, were received and approved.

#### 2) Dividend

That the aggregate of the net interim dividends declared by the Directors on 5 August,2022 amounting to €455,613 (equivalent to €0.020 per share), on 2 December, 2022 amounting to €227,806 (equivalent to €0.010 per share), and on 13 April, 2023 amounting to €113,903 (equivalent to €0.005 per share), in total amounting to €797,322 (equivalent to €0.035 per share), be considered the aggregate net dividend for the financial year ended 31 December, 2022, and such aggregate net dividend be and is hereby approved.
